

Privacy Policy

Effective as of September 4, 2023.

This Privacy Policy describes how Magniv, Inc. ("PromptLayer", "we", "us" or "our") handle personal information that we collect through our digital properties that link to this Privacy Policy, including our website (collectively, the "Service"), as well as through social media, our marketing activities, and other activities described in this Privacy Policy.
